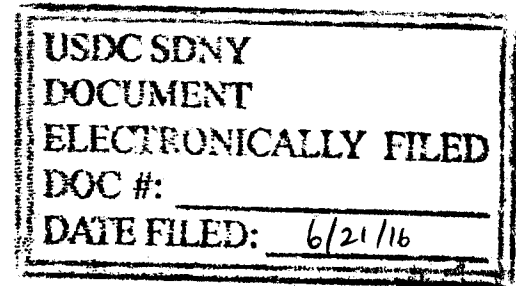

Re: ARAG-A Limited et al. v. The Republic of Argentina, No. 16-2238 (TPG)

Dear Judge Griesa:

We are co-counsel for plaintiffs and former plaintiffs in the above-referenced action, and for certain of the plaintiffs who are now prosecuting an appeal of this Court's April 12, 2016 order [Dkt. No. 57] (the "April 12 Order"). Certain plaintiffs and former plaintiffs in this action have reached settlement agreements with the Republic of Argentina (the "Republic") that require them to file a notice with this Court withdrawing from the above-referenced action.<sup>1</sup> While jurisdiction of this action is now with the Second Circuit Court of Appeals, we are requested and authorized by the Republic's counsel to comply with the parties' settlement obligations by submitting notice in the form of this letter, notifying the Court of those settlements and the current status of the litigation generally.

Accordingly, with the consent of the Republic, Plaintiffs and former plaintiffs ARAG-A Limited, ARAG-O Limited, ARAG-T Limited, ARAG-V Limited, Honero Fund I, LLC, MCHA Holdings, LLC, Red Pines LLC, Spinnaker Global Emerging Markets Fund Ltd., Spinnaker Global Special Situations Fund LP and Yellow Crane Holdings, L.L.C (together, the "Withdrawing Plaintiffs")<sup>2</sup> provide notice that each of the Withdrawing
